

Tom Ridge: GOP Must Do Better on the Environment

Richard Nixon founded the EPA. Teddy Roosevelt gave us National Parks. And until fairly recently, Republican politicians were among the leading voices advocating for conservation and the environment. What happened?

Two-term Pennsylvania governor and lifelong conservative Tom Ridge raised the question in an Earth Day essay for the *Atlantic*, taking his party to task for turning its back on the environment.

He expanded on that critique as a guest on PEC's <u>Pennsylvania Legacies podcast</u> last month. Citing multiple U.S. Department of Defense warnings of global instability due to climate change, the former Homeland Security director said conservatives ought to take their cues from the military and intelligence communities.

"If you don't believe the scientists, believe those in charge of your safety and security globally. And if that can't convince you, then I guess there's no convincing," Mr. Ridge said. "If the scientists and the military can't do it, I don't know who can."



Davies and Cotrone, who is a Penn State Extension urban forester, weren't planting corn or tomatoes on Wednesday, but trees.

They were among a half dozen volunteers from the Suskie Bassmasters and Riverfront Parks Committee who planted a dozen red maples and a willow near the boat launch in Wilkes-Barre's Nesbitt Park, using funds from a Keep America Beautiful grant that the local Pennsylvania Environmental Council applied for and received...

Down in the dumps: Poconos seeing rash of illegal dumping

Despite the stay-at-home order that has kept Pennsylvanians cooped up for the past month, reports of littering and illegal dumping have increased drastically across the commonwealth, including Monroe County...

Janet Sweeney, director of Keep Northeastern Pennsylvania Beautiful and Vice President of the Pennsylvania Environmental Council, said that she has also received reports of increased littering on state lands.

"I have also heard from several of my trail partners that there has been a noticeable increase in trail users and a corresponding increase in litter along the trails," Sweeney said. "It is very unfortunate that this resource, which is helping people cope with this situation, is also experiencing more littering by the people who are using at as a refuge of sorts. I know most of our trail partners have signed 'carry in carry out' and 'leave no trace' policies in place, but these are not always heeded."
