Nearing the End of Legislative Session

The Pennsylvania General Assembly's legislative session ends on November 30th. While taking a brief pause for the election, the legislature is expected to return next week to complete the state's operating budget. Normally the budget is finalized in June of each year, but due to the uncertainty of funding and expenditures caused by the COVID-19 pandemic the Assembly at that time decided to pass a temporary five month "stop gap" budget.



With questions about the availability of further federal stimulus measures and ongoing revenue shortfalls, any number of decisions could be made with respect to repurposing special funds like the Environmental Stewardship Fund (aka Growing Greener) and the Keystone Fund that are used for environmental cleanup, recreation, and conservation projects across the state. With the outdoors proving to be one of the few respites available for Pennsylvanians during this pandemic, and the use of our public lands and recreational amenities skyrocketing, demand on these resources has underscored their importance. PEC has been working to help quantify this increase.

It is critical that representatives hear from their constituents that these resources matter, so we urge you to lend your own voice toward protecting the Keystone Fund and Environmental Stewardship Funds. To do so, you can identify your legislators here.
